To qualify you must satisfy all of the following:

- You are a manufacturer or manufacturer's sales representative
- You are making no retail sales of any kind during the show
- **At least one of your dealers is in the show to sell your product**
- You may not share this space with any other company without approval from Show management

If accepted to this program, you would not be required to make cash payment. Instead you will donate your product to our fund-raising committee as follows: **\$250 product/value per in-line space; \$300 per corner/premium space (value is "wholesale" cost)**

Things you should know (please read):

- Your participation in the Show will **not be confirmed** until we receive the **signed contract** (which will be sent to you after acceptance)
- Booth locations will be assigned by Show management, but we will make every effort to accommodate any requests you have
- Booths are 10' long by 8' deep unless otherwise designated. Booths include an 8' back curtain and two 3' side curtains
- Booths **do not include table, chairs**, carpeting, electricity, phone service. Information on ordering will provided after January 1.
- Hours for the Show will be: Friday (12:00 p.m. to 8:00 p.m.), Saturday (9:00 a.m. to 7:00 p.m.), Sunday (10:00 a.m. to 5:00 p.m.)
The show ends at 5:00 p.m. on Sunday, March 24. Dealers may not dismantle their booth space before that time.
- Although some onstreet parking can be found in Providence, most exhibitors should use the Convention Center Parking Garage which is attached to the exposition center. Parking rates are currently \$15/day. A gated yard is available for trailers and trucks higher than 6'9", but all other vehicles will not be allowed to park there (R.I. Convention Center rules)
- No exhibitor will be allowed to drive any vehicle on the Convention Center floor
- The R.I. Convention Center is a unionized facility. Exhibitors who arrive in a "box" truck must be unloaded by union dock workers, *but* their fee is paid by the R.I. Saltwater Anglers Association during authorized move-in and move-out hours. Exhibitors who use private autos, vans or small trucks may unload without a dock laborer.
